**Nature of the Organization and Summary of Significant Accounting Policies**

Description of the Organization:

Oswego Lake Watershed Council (OLWC) is a 501(c)(3) educational nonprofit organization whose mission is to foster stewardship, education, participation, and financial support for the conservation, restoration, enhancement, and maintenance of watershed functions in the Oswego Lake watershed. The Organization is located in Lake Oswego, Oregon.

Income Tax Status:

OLWC is a non profit corporation exempt from federal and state income taxes under section 501(c)(3) of the Internal Revenue Code and applicable state law. OLWC is not a private foundation.

Donated Assets and Services:

OLWC received contributed services from volunteers who provided an estimated 834 hours during the year ended December 31, 2013 from volunteers who provided an estimated 365 hours during the year ending December 31, 2012. The value of the services, which OLWC considers not practical to estimate, has not been recognized in the accompanying financial statements.
